

**Sudden Service “Summer of
Fun” Sweepstakes
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN.

1. **SWEEPSTAKES DATES:** The Sweepstakes begins at 12:00 a.m. Central Time (“CT”) on June 7, 2021 and ends at 11:59 p.m. CT on August 30, 2021 (the “Sweepstakes Period”).
2. **ELIGIBILITY:** Sweepstakes is open to legal permanent residents of Kentucky, and Tennessee who are at least eighteen (18) years of age or older (or at least the age of majority in his/her state) at the time of entry (the “Entrant”). Employees, officers and directors of Tri Star Energy, LLC (the “Sponsor”) and each of its subsidiaries and affiliates, distributors, vendors, advertising/promotion agencies, and any others engaged in the development, production, execution or distribution of the Sweepstakes and the entities supplying the prize (collectively referred to herein as “Sweepstakes Entities”) as well as their immediate family members (spouses, siblings, children and parents, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible to participate. Upon completing the Online Form and clicking the “Submit” button, Entrant will receive one (1) entry into the Sweepstakes. Entrant can complete the Online Form each day to receive one (1) entry per day. In order to obtain an entry into the Sweepstakes, Entrant must complete all required fields listed on the Online Form. Any Entrant who does not complete the Online Form in its entirety; or aborts this entry process before it is complete will not receive an entry into the Sweepstakes.

Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant’s entries and that Entrant may be disqualified from the Sweepstakes. Entry information becomes property of Sponsor and will not be returned. Sponsor will not verify receipt of entries for Entrants.

5. **PRIZES:** Prizes to Nashville area events, exhibits and area activities along with a \$50 gift card will be awarded on a weekly basis. Prizes of cash and electronics will be awarded on a monthly basis. Total approximate retail value (“ARV”) varies by prize awarded.
