



# Tri Star Energy – Monster Energy Supercross Ticket Sweepstakes Official Rules

## **1. Sponsor.**

## **2. Eligibility.**

- Enter or scan your **linked loyalty account** at checkout;
- Receive **one (1) entry** per qualifying purchase transaction.

### **B. Points Redemption Entry**

- Redeem **500 points** in your loyalty app/account for one (1) entry.
- Must have sufficient points at the time of redemption.

### **C. No Purchase Necessary (Mail-In Entry)**

Limit one mail-in entry per envelope.

#### **5. Prizes & Approximate Retail Value (ARV).**

There are **two (2) total prizes**, awarded as follows:

- **Prize #1:**

Awarded to **one (1) winner** drawn from the Twice Daily & White Bison Rewards entry pool.

Includes **four (4) general admission tickets** to the **Monster Energy Supercross** on **April 11, 2026** in Nashville, TN.

- **Prize #2:**

Awarded to **one (1) winner** drawn from the **Sudden Rewards** entry pool.

Includes **four (4) general admission tickets** to the same event.

Potential winners will be notified via **telephone and email** using the contact information associated with their loyalty account. If Sponsor is unable to reach a potential winner after **three (3) attempts within five (5) days**, or if the winner is deemed ineligible, Sponsor may select an alternate.

Winners may be required to complete and return an **Affidavit of Eligibility, Liability Waiver**, and **Publicity Release** within five (5) days of notification.
