



# Summer of Fun Sweepstakes: Official Rules

By entering this sweepstakes, you agree to the following official rules ("Official Rules"):

**Sponsor:** The sponsor of this sweepstakes is Tri Star Energy ("Sponsor"), with an office at 1740 Ed Temple Blvd. Nashville, TN 37208 (address).

**Eligibility:** The sweepstakes is only open to persons who are at least (i) 18 years of age on the date of entry, and (ii) U.S. residents, excluding residents of Florida, New York, or Rhode Island.
